The abstracts must not exceed one page (A4) and are to be set out in WinWord with .RTF extension format in Russian and/or English. The abstracts should not contain tables or pictures. Each Forum participant may not be a co-author of more than two papers.

The text must be typed out as one width-aligned column set out in 1 space. Each paragraph should begin with a new line (1cm indented). The font used is Time New Roman 11. All margins are 2.5 cm. The space between the title and the text of the abstract should be two blank lines. Symbols to be used are clipped from the Symbol type-face set, equations are edited using Microsoft Equation.

Organising Committee leaves the right to decline abstracts set out in contravention of the topics of the meeting or composed out of rules, as well as designate the form of participation.
